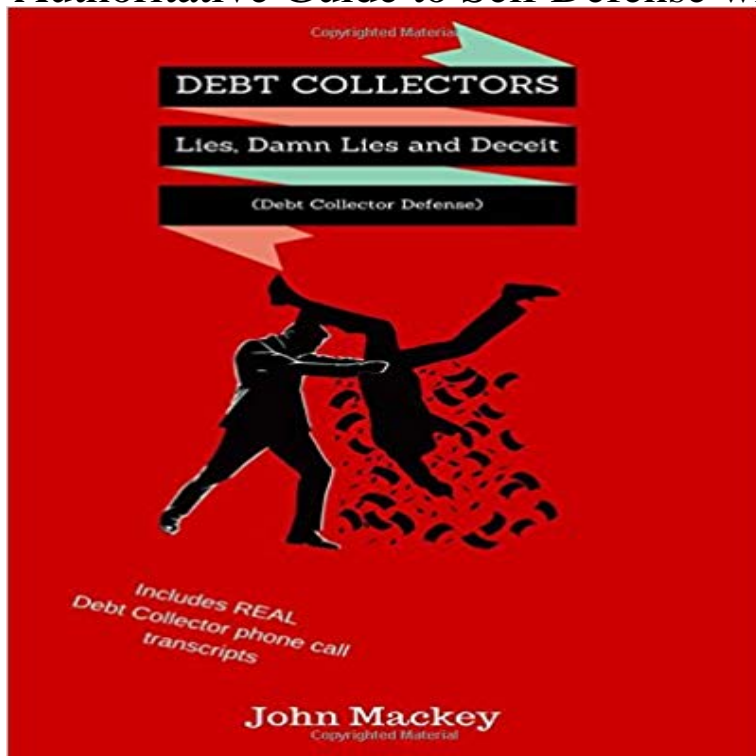


# Debt Collectors: Lies, Damn Lies and Deceit: The Complete Authoritative Guide to Self Defense with Debt Collectors
